Designed as a voluntary service, the Nursing Home Leadership Coach is able to assist with such issues as Operational Improvement, Corporate Compliance, Budget Analysis, Regulations, Process Improvement Leadership Skills, Staff Retention, Contract Review, Survey Readiness, Staff Training, Quality of Life and Culture Change. The Coaching Service will be working collaboratively with the MU QIPMO program, which has been in place since 1999, providing nursing homes with evidence-based clinical information related to the care of the elderly in Missouri's nursing homes.

The Missouri Department of Health and Senior Services, worked with the Sinclair School of Nursing to develop the Coaching Service in 2011 in an effort to increase access to current and relevant information and advice that will assist Missouri nursing home administrators in their management roles.
