On February 20, 2015 CMS unveiled Nursing Home Compare (NHC) 3.0 and strengthened NHC 5-Star Quality Rating System. Two additional quality measures were added, performance expectations were raised, staffing algorithms were adjusted and targeted surveys were expanded. Review all of these changes and see how the 5-star system really works and how to make sure you are managing for the best possible rating for your facility. Learn about a new system "Payroll based staffing reporting" audited back to payrolls which will verify staffing. The new system will be initiated in 2015 and all nursing homes will be using it by the end of 2016.
