Section for Medical Marijuana Regulation (SMMR)

- ☐ In 2018 Amendment 2 was passed into law, legalizing the use of medical marijuana for qualifying Missouri patients
- □SMMR was created to oversee the medical marijuana regulatory program, which provides four primary functions:
 - ➤ Patient Services
 - ➤ Operations
 - > Facility Licensing
 - ➤ Facility Compliance
- ☐ Lyndall Fraker has been Section Administrator for SMMR since 2019



Division of Regulation & Licensure

Time Critical Diagnosis Unit (TCD)

- ☐ Is Missouri's statewide emergency medical care response system to provide a quicker response and higher quality care when a time critical emergency happens
- ☐ Brings together the 9-1-1 system, Emergency Medical Services, and hospitals in a coordinated approach
- ☐ Hospitals can receive designations as a trauma center, stroke center, or STEMI (heart attack center) to provide 24/7 access to treatment and recovery
- ☐ Nicole Gamm has been Program Unit Manager for TCD since 2016



Section for Health Standards & Licensure (SHSL)

- ☐ Has regulatory responsibility for:
- ☐ Hospitals, ambulatory surgery centers, birthing centers, Dialysis facilities, Abortion facilities
- □X-ray services, Laboratory services / CLIA Clinical Laboratory Improvement Amendment
- ☐ Hospice, Home Health Care
- □ Emergency Medical Services, Narcotics & Dangerous Drugs
- ☐ Food Safety, Lodging, and Restaurant/Food Inspection (working with Local Health Agencies)
- ☐ Bill Koebel has been Section Administrator for SHSL since 2017



Division of Regulation & Licensure

Family Care Safety Registry (FCSR)

- ☐FCSR was established by law to promote family and community safety
- ☐ Helps protect children, seniors, and people with disabilities by providing background information to families and employers regarding personal care, elder care, and child care workers
- □ Provides information to help families and employers make informed decisions when hiring employees to work with children, the elderly, and people with disabilities
- ☐ Melanie Madore has been FCSR Unit Chief since 2009



Board of Nursing Home Administrators (BNHA)

- □BNHA was established to protect and advocate for Missouri's long term care residents by licensing prospective and current long term care facility administrators
- ☐ Works to ensure the highest quality of care possible
- □ Develops and enforces standards for long term care administrator, facilitates the licensing examination, issues and renews licenses, investigates complaints, and reviews/approves continuing education for administrators
- □Sally McKee has been Board Coordinator for 12 years



Division of Regulation & Licensure

Certificate of Need Program (CON)

CON is an effort to contain costs, improve quality, and increase access for many of Missouri's major medical health care services

Reviews an approves requests for new and replacement facilities and major medical equipment above a specified cost threshold

Includes hospitals, long term care facilities, major medical equipment

Alison Dorge has been Program Manager for CON since 2019



Section for Long Term Care Regulation (SLCR)

SLCR is responsible for regulating, licensing, and overseeing operations of Missouri's long term care facilities to ensure residents receive safe, appropriate, high quality care

Comprised of multiple units, including Licensure and Certification, Regulation & Compliance, Quality Assurance and Education, Health Education, Regulation, and Intermediate Care Facility/Intellectually Disabled

7 Regional Offices - Region 1 - Springfield; Region 2 - Poplar Bluff; Region 3 - Kansas City; Region 4 - Cameron; Region 5 - Macon; Region 6 - Jefferson City; Region 7 - St. Louis
